

WHO LET THE DOGS OUT ????

Upon reaching five months of age, all dogs must be licensed and have an active rabies vaccination certificate from a licensed veterinarian. Please remember that all dog licenses expire on December 31 of each year. Your dog is not licensed for the current year until you apply for it. State Laws and Portage County Ordinance require that all dogs are to be vaccinated and licensed.

You may license your dog via mail or at the Town Hall office. A spayed or neutered dog is \$12.00 and dogs that are not spayed or neutered cost \$22.00. If you no longer have a dog that was licensed previously, please call the town office.

Below is a comparison of our Town of Sharon Real Estate and Personal Property Tax between 2017 and 2018 based on what we supplied to the Wisconsin Department of Revenue.

Are you thinking, what does this tell me? Every entity needs money to support their budget. Our town has multiple school districts, depending on your geographical location, if you reside within the Rosholt School District, you help support them and the North Central Tech College. If you reside within the Stevens Point School District, you help support them and the Mid State Tech College. Our town allotment has decreased from last year. Even though the total overall property taxes has increased, the town portion went down.

year the town received \$158.00 for every \$1000 paid in taxes, this year the town will receive \$146.00 for every \$1000 paid in taxes. Your town tax dollars pay for your town board salaries, clerk/treasurer salary, two full time town employees, one part time and seasonal workers, all elections, fire protection, first responders, garbage/recycling, routine maintenance/repair/paving/chip sealing/snowplowing/brush and tree removal on approximately 69 miles of town roads. These items are just a taste of where your tax dollars are spent. Based on our share, we spread the dollars as far as we can. If an unbudgeted, unexpected expense arises and is needed immediately, the board will attempt to secure a loan to help us continue moving forward. In other words, we budget just like you do at home.

WHAT ABOUT THEM ROADS??????

That is the question of the century. There are pot holes, cracked pavement, no pavement, gravel roads, damaged culverts, bumps, lumps ... you name it, it's somewhere in our township. It's not going away and its frustrating. The Wisconsin Department of Transportation provides our municipality with an annual General Transportation Aid payment (GTA). This stipend is based on data the municipality provides to the WI DOR in its Municipal Financial Report in addition to miles reported. In 2016 & 2017, the town received \$152,268.00. In 2018 & 2019, the town received \$165,199.00. This money is used to repair/rebuild/maintain approximately 69 miles of town roads. For example: the town received a quote to rebuild Hillcrest Road, 9410 ft, the quote was \$561,511.18; quote to rebuild Merryland Drive was \$203,321.00. Based on our limited resources, the GTA money doesn't cover our needs, but supplements them. The town can only stretch so far without taking on additional loans and increasing property taxes.

AGING AND DISABILITY RESOURCE CENTER OF PORTAGE COUNTY (ADRC)

In 2018, the ADRC nutrition program began a new phase, transitioning from a catered meal program to an on-site cooking kitchen. It is referred to as MY MEAL MY WAY program and kicked off in January at the Sunshine & Grzyba's Rosholt Café. The purpose of this program is to promote health and independence, balanced nutrition and social interaction. The program is funded and designed to provide meals and supportive services to people 60 years of age and over, and their spouses. MY MEAL MY WAY offers a meal to seniors on Monday, Wednesday and Friday (8:30 AM—1 PM) in the Rosholt community. Diners will choose from several menu options (breakfast or lunch) and pay on a donation basis posted at the restaurant. No eligible participant will be denied a meal based on ability to contribute toward the cost of the meal. Reservations are not required
